THINGS TO CONSIDER

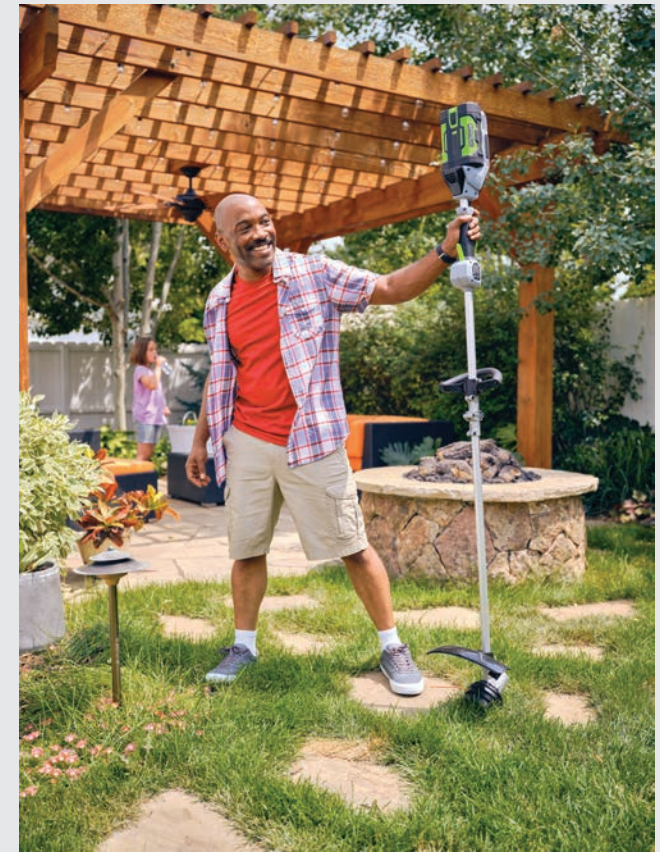
They are low maintenance. With electric models, you don't need to store gasoline, perform oil changes, treat fuel, change spark plugs or change filters.
